# COMPETITIVE EXAMINATION FOR DIRECT RECRUITMENT IN THE DISTRICT JUDGE CADRE, 2018

In continuation to the Notification No. RHC/ExamCell/RJS/DJC/2017/67 Dated: 10/02/2017 & Corrigendum No. RHC /EXAM.CELL/RJS/DJC/2017/226 Dated: 08-05-2017, saving existing application forms of the eligible candidates for the Recruitment of District Judge Cadre, 2017, this Notification is hereby issued as under:-

1. On-line Applications are invited in the prescribed format from the eligible Advocates for direct recruitment for vacant posts (shown in the chart) in the District Judge Cadre of Rajasthan Judicial Service in accordance with the provisions of Rajasthan Judicial Service Rules, 2010 (As amended from time to time) (hereinafter referred to as 'Rules') in pay scale of Rs. 51550-1230-58930-1380-63070. (Unless contrary appears from the context, the pronoun "he" and its derivatives are used of any person, whether male or female hereinafter in the Notification).

#### Note:

- Notification and instructions issued for filling on-line application thoroughly prior to filling of on-line application for the post, which are available on the official web-site of Rajasthan High Court (<a href="http://www.hcraj.nic.in">http://www.hcraj.nic.in</a>) and ensure that they fulfil all the requirements of eligibility as per the 'Rules'. If any of the candidates is found ineligible or his ineligibility is detected at any later stage, his candidature shall liable to be rejected.
  - (ii) Candidates must furnish all the relevant information required in the on-line application. Furnishing of false and/or incomplete information shall lead his application to rejection for which he will be solely responsible.

- (ii) Reservation to the OBC category will be given as per the list notified (as amended from time to time) for OBC (NCL).
- (iii) Reservation for woman including widows and divorcee shall be Horizontal reservation within the category, meaning thereby the selected woman will be adjusted in relevant category (SC/ST/OBC/General) to which she belongs.

- (iv) In case of non availability of eligible candidates of SC, ST and OBC category of Rajasthan, Women and PH candidates, the reserved posts shall be filled in as per the procedure prescribed in the 'Rules'.
- (v) A Married Woman desirous of getting benefit of reservation in the category of Scheduled Caste, Scheduled Tribes and Other Backward Classes shall have to produce Caste/Class Certificate issued with the name of her father; Parental Address and Parental income failing to that the reservation claimed for shall not be allowed in light of Circular No. F.15(24)DOP/AII/75 Jaipur dated 24.06.2008 of Department of Personnel (A-II), Govt. of Rajasthan.
- (vi) Candidates of Scheduled Castes, Scheduled Tribes and Other Backward Classes categories belonging to the States other than Rajasthan shall be treated as candidate of General category.
- (vii) Candidates of Reserved categories (SC/ST/OBC) selected against General category must have all required eligibilities as of candidate of General category.
- (viii) Reservation to the Persons with Disabilities (Differently Abled) shall be Horizontal, meaning thereby the selected Person with Disabilities will be adjusted in relevant category (SC/ST/OBC/ General) to which he belongs, as per the applicable provisions.
- (ix) Candidate applying in this category shall have to produce certificate of his disability in prescribed format whenever required by the Rajasthan High Court, duly issued by a Medical Board consisting of 3 Medical Officers constituted by a Govt. Hospital of State of Rajasthan. Candidates having certificate of disability of 40% or more issued by the Medical Board shall be eligible for the selection and appointment against the post reserved for Persons with Disabilities.

#### 3. AGE:

A candidate for direct recruitment to the service must have attained the age of 35 years and must not have attained the age of 45 years on the  $1^{\rm st}$  day of January 2019.

(a) Provided that the upper age limit mentioned above shall be relaxed by 5 (five) years in case of candidates belonging to the Scheduled Castes, Scheduled Tribes, Other Backward Classes and Women Candidates.

- (b) The age relaxation would be given as per the Rules.
- (c) A candidate earlier applied in persuance of the Notification No. RHCJ/Exam Cell/RJS/DJC/2017/67 dated 10.02.2017 and corrigendum No. RHCJ/Exam Cell/RJS/DJC/2017/226 dated 08.05.2017, need not to apply again. If he/she was reckond eligible or is having an order of the court in their favor. The consideration of their candidature against the vacancies under this Notification would be subject to eligibility with regard to their age.

#### 4. **ELIGIBILITY**:

A candidate for direct recruitment to the service:

- (i) must be a Citizen of India;
- (ii) must hold a degree of Bachelor of Laws (Professional) of any University established by Law in India and recognized as such under the Advocates Act, 1961;
- (iii) must have been an Advocate for a period of not less than seven years on the last date fixed for submission of online application i.e 10.10.2018; and
- (iv) must possessess a thorough knowledge of Hindi Written in Devnagri Script and Rajasthani Dialects and Social Customs of Rajasthan.

## 5. CHARACTER, FITNESS AND LENGTH OF ACTUAL PRACTICE:

(i) The character of a candidate must be such as to render him suitable in all respects for appointment to the Service. He must produce a certificate of good character, as to fitness and length of actual practice from the District Judge of the District in which he has been practicing as a lawyer and two such certificates, written not more than six months prior to the date of submission of application form, from two responsible persons not related to him.

In case, the applicant is practising in the High Court, the certifying authority shall be Registrar of the concerned High Court.

(ii) A person dismissed by Central Government or by the State Government or convicted of an offence involving moral turpitude or any such offence, which in the opinion of the

- Recruiting Authority renders him unsuitable for appointment in Judicial Service shall not be eligible for appointment.
- (iii) No person shall be appointed as a member of the Service unless he is in good mental and bodily health and free from any physical defect likely to interfere with the efficient performance of his duties as a member of the Service. Before a candidate is finally approved for appointment by direct recruitment, he shall be required to appear before a Medical Board which will examine him and certify if he is fit for appointment to the service.

## 6. <u>DISQUALIFICATION FOR APPOINTMENT</u>:

No person shall be qualified for appointment to the Service or being in Service:

- (i) if he has more than one spouse living;
- (ii) if he has been dismissed or removed from service by any High Court, Government or Statutory Body or Local Authority;
- (iii) if he was or is convicted for any offence involving moral turpitude or has been permanently debarred or disqualified by any High Court or Union Public Service Commission or any State Public Service Commission from appearing in any examination or interview;
- (iv) if he, being an Advocate, was found guilty of professional misconduct under the provisions of Advocates Act, 1961 (Central Act 25 of 1961) or other law for the time being in force;
- (v) if he has more than two children on/or after the date of commencement of the "Rules".

Provided that the candidate having more than two children shall not be deemed to be disqualified for appointment so long as number of children he/she has on the date of commencement does not increase:

Provided further that where a candidate has only one child from earlier delivery but more than one child is born out of a single subsequent delivery, the children so born shall be deemed to be one entity while counting the total number of children.

**Explanation:** For the purpose of this clause, child born within 280 days from the date of commencement of the "Rules" shall not constitute disqualification.

Note: The Rajasthan Judicial Service Rules, 2010 came into force w.e.f. 19.01.2010.

(vi) if he has accepted or accepts dowry at the time of his marriage.

Explanation: In this clause, the word "dowry" shall have the same meaning as assigned it in Dowry Prohibition Act, 1961 (Central Act 26 of 1961).

#### SCHEME OF EXAMINATION AND SYLLABUS: 8.

The Competitive Examination for Direct recruitment in the District Judge Cadre, 2018 shall consist of Written Examination and Interview.

#### Note:-

- 1. Recruiting Authority shall be at liberty to adopt the mode of shortlisting, if required, in the event number of candidates to be admitted to the written examination is higher.
- 2. Merit of the candidates securing same aggregate marks shall be determined on basis of the higher marks obtained in Interview. The merit of the candidates who are having same aggregate marks with equal marks even in Interview shall be determined by giving higher preference to the candidate who was enrolled as Advocate on earlier date.

The Scheme of the written examination for competitive examination for recruitment to the District Judge Cadre shall consist of (a) a written examination in the subjects mentioned hereinafter, and (b) an interview to test the general knowledge of the candidate and his fitness for appointment to the Cadre.

Interview: - In interviewing a candidate, suitability for employment to the Judicial Service in the Cadre of District Judge shall be tested with reference to his record at the School, College and University, and his character, personality, address and physique. Question which may be put to him may be of a general nature and will not necessarily be academic or legal. The candidate will also be put questions to test his general knowledge including knowledge of current affairs and present day problems. Marks shall also be awarded for the candidate's proficiency in the Rajasthani dialects and his knowledge of social customs of Rajasthan. The marks so awarded shall be added to the marks obtained by each candidate in the written test.

#### HOW TO APPLY:

On-line applications shall only be accepted.

- The candidate may fill-in on-line application through his own computer & printer with internet facility or with help of service provider who provides service of computer & printer with internet facility like Cyber cafe, e-Mitra kiosk etc., the charges of which shall be borne by the candidate.
- 2. Before filling on-line application, the candidates are required to carefully read instructions issued for filling on-line application.
- 3. - 4. A candidate may also send print-out of his online application alongwith required documents by Registered/Speed Post (Not by Courier or ordinary post) at his own risk and in that event his application shall be accepted on being received in the office of Registrar (Examination), Rajasthan High Court, Jodhpur on or before the last date prescribed for submission for print-out of online application.
  - 5. The print-out of online application with documents and fee received after last date for submission for print-out of online application shall not be scrutinized for admission to the examination.

#### 11. ADMIT CARDS:

- a. <u>Scrutiny of Applications</u>- The Committee constituted by the Chief Justice shall scrutinize the applications and shall satisfy itself before granting certificate in each case that the application has been made strictly in accordance with the provisions of Rajasthan Judicial Service Rules, 2010 and the decision as to the eligibility or otherwise of the candidates for admission to the examination shall be final. No candidate shall be admitted to the examination unless he holds a certificate of admission issued by the person authorized by the Chief Justice.
  - b. Admit Cards shall be issued through official website of Rajasthan High Court (<a href="www.hcraj.nic.in">www.hcraj.nic.in</a>). Admit Cards shall not be sent to the candidates through any other mode. The candidates are advised to keep visiting the website regularly. The candidate can download Admit Card by entereing his Application ID, Date of Birth & Captcha. The candidates may obtain print-out of Admission Card through his own computer & printer with internet facility or with help of service provider who provides service of computer & printer with internet facility like Cyber cafe, e-Mitra kiosk etc.

## 12. DATE & PLACE OF EXAMINATION:

The Written Examination is likely to be held at Jaipur and Jodhpur but in case the number of candidates applying for the post is large, the examination may additionally be held at other places also. The information regarding examination centres and date of the examination shall be published on the official web-site of Rajasthan High Court (www.hcraj.nic.in) separately.

## 13. IMPORTANT INFORMATION:

- The candidates, who were found eligible for written examination in the District Judge Cadre, 2017, need not to apply afresh.
- II. The candidates, who were provisionally allowed by the order of Hon'ble Supreme Court and Rajasthan High Court, and also found otherwise eligible to participate in the written examination of District Judge Cadre, 2017, and their writ petitions are still pending, need not to apply afresh. List of above eligible candidates is simultaneously being uploaded with the Notification on the official website of the Court.
- III. If, any candidate, who had applied earlier in pursuance of notification No. RHCJ/ Exam Cell/ RJS/ DJC/ 2017/ 67 dated 10.02.2017 and corrigendum No. RHCJ/ Exam cell/ RJS/ DJC/ 2017/ 226 dated 08.05.2017, is desirous to change his category, has to apply afresh.
- IV. Every candidate shall furnish particulars of 10 Judgements of the preceding seven years in which he has argued personally in the **prescribed format** as **ANNEXURE V** available at the official website of this Court. He shall produce certified copies of such Judgments at the time of interview also.
- V. No candidate shall be allowed to bring/posses/keep with him Cellular Phone, Calculator, Bluetooth or any other electronic/communication device and Purse etc. in the examination centre. Candidates are allowed to bring only pen, pencil, admit card or any other material as specifically directed by the Rajasthan High Court in examination room. Centre Superintendent/Rajasthan High Court shall not be responsible for safety of above gadgets.
- VI. Every candidate shall himself write answers to the questions in the examination, however, the facility of Scribe will be provided to such persons as per existing Rules, who are unable to write the answer at his own if they make request in writing to the Registrar (Examination), Rajasthan High Court, Jodhpur to provide the facility of Scribe at least 15 days prior to the date of Examination with

prescribed certificate of such disability. Such facility will not be provided to the persons who temporarily or accidentally get disabled.

- VII. All the candidates shall comply with the instructions issued by the Rajasthan High Court/ Centre Superintendent/ Invigilator/ Officer authorised by Rajasthan High Court. If any candidate does not comply the instructions or found using unfair means, action as deemed appropriate by the High Court may be taken including under Rajasthan Public Examination (Prevention of Unfair Means) Act,
- VIII. A candidate who is or has been declared by the Recruiting Authority or the Appointing Authority, as the case may be, guilty of impersonation or of submitting fabricated or tampered with documents or of making statements which are incorrect or false or of suppressing material information or using or attempting to use unfair means in the examination or interview or otherwise resorting to any other irregular or improper means for obtaining admission to the examination or appearance at interview shall, in addition to rendering himself liable to criminal prosecution, be debarred either permanently or for a specified period,-
  - (a) by the Recruiting Authority or the Appointing Authority, as the case may be, from admission to examination or appearing at interview held by the Recruiting Authority for selection of candidates, or
  - (b) by the Government from employment under the Government.
